

# Privacy Policy

Welcome to RoyRPachiMusic.com (the "website"), operated by Roy R Pachi and its affiliates ("we" or "us").

We respect your right to privacy and have established this policy to explain what personal information we will collect from you when using the website, how we use that information and how we comply with the National Privacy Principles under the Privacy Act 1988 (Cth).

You do not need to provide us with any personal information in order to be able to use the basic features of our website. However, you may not be able to receive our mailing list, buy merchandise if we setup an online store in the future, or participate in some of the activities we offer if you choose not to do so.

Currently this site is operating as an information and promotional site. When music is made available, it will be through other websites, such as iTunes. We are not responsible for those websites. We suggest that you take a look at their privacy policy if you want to know how they will collect, store or use your personal information.

Your access to and use of this website constitutes acceptance by you of this Privacy Policy.

## **What personal information is collected by us?**

The type of personal information which we will collect from you depends on how you use the website. If you wish to subscribe to our mailing list, then you will need to provide us with your name and email address.

We may also collect data relating to your general Internet usage. That data may include IP addresses, browser version, number of visits and similar such data relating to your use of the Internet and website.

## **How do we collect that information?**

Generally we collect your personal information when we ask you to fill out an online form or when you contact us. In addition, we may use "cookies", "log files" and "pixel tags" to collect data relating to your general Internet usage.

A "cookie" is a small text file placed on your hard drive. Cookies help us to improve our website and to deliver a better and more personalised service, for instance by storing information about your preferences and allowing us to recognise you when you return to our website. You can disable cookies by turning them off in the preferences or settings menu of your Internet browser. But you may not be able to visit or participate in some parts of the website.

A "log file" gathers similar information to a cookie. However, it does not identify individual users. We may use log file data to identify usage trends, to administer the site, to track users' movements around the website and to gather demographic information about our users collectively.

A "pixel tag" is a small graphic placed on a webpage that tells us what parts of our website users have visited or to measure the effectiveness of searches users perform on our site. ## **How do we use your personal information?**

We use the personal information collected from our website in the following ways:

- to provide you with information, products or services that you have requested from us or which we feel may interest you;
- to ensure our website is presented in the most effective manner for you;
- to deliver any merchandise which you order from us;
- to contact you if you win a prize in a competition you have entered on this website and to send the prize to you;
- to allow you to participate in interactive features of our service, when you choose to do so;
- to notify you about changes to our services; and
- to interact and correspond with you.

## **Will we give your information to someone else?**

Where appropriate, we may share your personal information with the following:

- we may share your personal information with Roy R Pachi (or his management company);
- we may share your personal information with our affiliates and third party service providers to provide you with products or services related to Roy R Pachi, or to improve the website; or
- we may disclose personal information if required to do so by law.

## **Security of your data over the Internet**

Unfortunately, the transmission of information over the Internet is not completely secure. Any transmission is therefore at your own risk. Once we have received your personal information, we will use reasonable and appropriate procedures to prevent unauthorised access. However, we cannot guarantee that any information you submit to us will be free from unauthorised third party intrusion. You release us from all loss or damage that you suffer or incur because of any unauthorised access to your personal information.

## **Your right to remove yourself from our mailing list**

On every email you receive from us, we'll give you the option to unsubscribe. We're not into spamming people. If you want to unsubscribe, we'll remove your email address permanently from the mailing list.

## **Other websites**

Our website may contain links to other websites which are outside our control and are not covered by this privacy policy. If you access other sites using the links provided, then the operators of those sites may collect and process personal information from you in a way that is different to how we do so. # Spam Policy
